1. Call to order 10:02 a.m.
2. Online Meeting Operating Protocol was presented and discussed.
3. Board Roll Call: Present---Brummund, Scully, Dailey, Baier, Huebel, Strauer, Vaughn. There was a quorum.
Total of 15 participants joined zoom meeting, 7 of which were board members.
4. Agenda: Motion made by Dailey/Brummund to approve Agenda as presented. Roll call vote on motion: Ayes: Brummund, Dailey, Scully, Strauer, Vaughn, Baier, Scully. Nays: none. Motion passed.
5. Minutes: Motion made by D Dailey/Brummund to approve Minutes of the 9/3/2020 meeting as presented. Roll call vote on motion: Ayes: Dailey, Brummund, Vaughn, Strauer, Baier, Huebel, Scully. Nays: none. Motion passed.
6. Public Comments: none
7. Old Business:
 - a) Resolution 2020-3 Cedar Lake Management & Weed Control Special Assessment District disclosures regarding error and typo corrections that have been made since last meeting:
 - i. Correction of two (2) typos on the Supervisor's Certificates on the Cedar Lake Management & Weed Control Assessment Rolls
 - ii. The only change was replacing the phrase "Special Assessment Roll for the Cedar Lake Special Assessment District No. 1" with "Special Assessment Roll for the Cedar Lake Management & Weed Control Special Assessment District". This change only corrects the formal name of the District, no changes made to the actual Rolls. The corrected and re-signed corresponding Supervisors Certificates added to the last page of each Township Assessment Roll as a supplement to the original signed Certificates.
 - iii. Motion made by Brummund/Dailey to accept corrections to the Supervisors Certificates as presented. Roll call vote on motion: Ayes: Scully, Baier, Huebel, Strauer, Vaughn, Dailey, Brummund. Nays: none. Motion passed.
8. Motion made by Brummund/Scully to recess the public meeting for the Public Hearing. Roll call vote on motion: Ayes: Baier, Huebel, Brummund, Scully, Dailey, Strauer, Vaughn. Nays: none. Motion passed.
9. Open Public Hearing
 - a) Board Roll Call: Brummund, Scully, Dailey, Baier, Huebel, Strauer, Vaughn. There was quorum.
 - b) A review of the progress and status of Special Assessment process was given by Vaughn. He included the number of meetings, public hearings, public viewing, newspaper ads, mailings, etc, that have been completed to date. Vaughn stated that today's Public Hearing is for the purposes of reviewing the overall special assessment roll (i.e. the combined tax assessment roll for Greenbush Township and the tax assessment roll for Oscoda Township) and for hearing all persons interested in that overall special assessment roll and any objections to the roll.
 - c) A presentation and review of the overall special assessment roll (i.e. the combined tax assessment roll for the Township of Greenbush and the tax assessment roll for the Charter Township of Oscoda) was presented by Vaughn,
 - d) Hearing opened for Public Comments:
 - i. Comments from persons present in the online Public Hearing:

>Brian Vokal, 4900 E Cedar Lake Dr, Greenbush, MI, wanted to confirm the assessment distribution and amount is the same as the recently expired special assessment and that this is actually a renewal and nothing new. Vaughn confirmed. Vokal voiced his support of the special assessment.

>Thelma Socia, 7740 W Cedar Lake Rd, Greenbush, MI, voiced her support of the special assessment.

>Barbara Hoover, 4810 E Cedar Lake Dr, Greenbush, MI, asked how the assessment roll was developed especially in regard to deeded easement property. Vaughn and Nancy Schwickert, assessor for both townships involved, answered Hoover's questions. Much discussion.

ii. Written remarks: There were none received by the Board as of Thurs, Sept. 24, 2020 @2:30 pm post office box pick up. However, Vaughn did receive written communication from Steve Wusterbarth, 7270 Shore View Dr, Oscoda, MI, regarding parcels in question at St George's Point that were brought up at the last public hearing. He indicated in the communication that Wusterbarth and Schwickert worked together and resolved the number involved and are accurately placed on the roll.

iii. Motion made by Brummund/Dailey to close the Public Hearing. Roll call vote on motion: Ayes: Vaughn, Scully, Dailey, Baier, Strauer, Brummund, Huebel. Nays: none. Motion passed.

10. Reconvene Regular Board Meeting

Board Roll Call: Present: Brummund, Scully, Dailey, Baier, Huebel, Strauer, Vaughn. There was a quorum.

11. New Business:

a) Review Cedar Lake Management & Weed Control Special Assessment District: Vaughn reviewed the steps and signatures needed to consider adopting the Special Assessment. Part of his review included the adjustment on the final total assessment value based on the small change in the total of number of parcels to be assessed as confirmed by the certified assessment rolls: 9 fewer, resulting in 751 not 760 actual parcels and a total revenue from the assessment reduced by \$1,350/year but per parcel assessment remains at \$150.00/parcel per year. Resolution 2020-4 includes the disclosure of the change of total number of parcels to be assessed and the reduction in the assessment total.

**CONFIRMATION OF THE SPECIAL ASSESSMENT ROLL; LIEN;
PAYMENT AND COLLECTION OF SPECIAL ASSESSMENTS**

Minutes of a public hearing of the Cedar Lake Improvement Board (“Board”) having jurisdiction in Alcona County and Iosco County, Michigan, held via electronic video conferencing on September 25, 2020, at 10:00 a.m., local time.

PRESENT: Board Members: Carolyn Brummund, Jim Baier, Dave Dailey, Fred Strauer, Al Scully, Rob Huebel, Rex Vaughn

ABSENT: Board Members: None

The following resolution was offered for adoption by Board Member Brummund and supported by Board Member Dailey

WHEREAS, the Cedar Lake Improvement Board, pursuant to MCL 324.30901 *et seq.*, as amended (“the Act”), has resolved its intent to make public improvements which shall consist of the control and partial eradication of aquatic plants and weeds within Cedar Lake by means of chemical treatment, biological agents, and/or mechanical harvesting, as well as lake management activities and lake studies and reports (collectively, the “Public Improvements”); and

WHEREAS, the Township Supervisors for the Township of Greenbush and the Charter Township of Oscoda have each prepared and certified a special assessment roll (comprised of the combined assessment rolls for the Township of Greenbush and the Charter Township of Oscoda) for the purpose of specially assessing that portion of the cost of the Public Improvements to the properties specially benefited thereby, and the same was presented to the Board and filed in the office of the Chairman of the Cedar Lake Improvement Board for public examination; and

WHEREAS, after notice duly given pursuant to the Act, the Board held a public hearing via electronic video conferencing on the 25th day of September, 2020 at 10:00 a.m. to consider the proposed special assessment roll and any objections thereto for the Public Improvements; and

WHEREAS, after hearing all persons interested therein, giving due consideration to any written objections to the overall special assessment roll filed with the Chairman of the Cedar Lake Improvement Board, and after reviewing the special assessment roll, the Board deems the special assessment roll to be fair, just and equitable, and that each of the assessments contained thereon is relative to the benefits to be derived by the parcels of land assessed.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. That the said special assessment rolls prepared by the Township Supervisors for the Township of Greenbush and the Charter Township of Oscoda as combined and reported to the Board in the total amount of One Million One Hundred Twelve Thousand Six Hundred Fifty Dollars (\$1,112,650.00) (or \$112,650.00 per year), for the Cedar Lake Management & Weed Control Special Assessment District, a copy of which is attached hereto as Exhibit A, is hereby confirmed and shall be known and designated as the Cedar Lake Management & Weed Control Special Assessment District Roll (collectively, the "Roll").

2. That the Chairman for the Cedar Lake Improvement Board, the Township of Greenbush Clerk and the Charter Township of Oscoda Clerk shall each endorse on the Roll the date of this meeting as the date of confirmation of the Roll.

3. That the assessments in the Roll shall be divided into ten (10) annual installments (i.e. one installment per year), the first of which shall be due and payable on or before December 1, 2020, and the following installments to be due on or before the first day of the same month of each year thereafter.

4. That all unpaid installments prior to their transfer to the tax roll as provided by the Act, as amended, shall bear interest payable annually on each installment due date at the rate of six percent (6%) per annum commencing on the due date of the first installment as set forth in this Resolution. Any payments before such first installment due date shall not bear any such interest.

5. That future due installments of an assessment against any parcel of land may be paid to the Township Treasurer of the Township of Greenbush or the Charter Township of Oscoda (as applicable) at any time in full, with interest accrued through the month in which the installments are paid.

6. If an installment of a special assessment is not paid when due, then the installment shall be considered to be delinquent and there shall be collected on the installment, in addition to the interest provided in paragraph 4, above, a penalty at the rate of one half of one percent (1%) for each month or fraction of a month that the installment remains unpaid before being reported to the Board for reassessment upon the tax roll as provided in the Act.

7. That all special assessments contained in the Roll, including any part thereof deferred as to payment, shall, from the date of confirmation of the Roll, pursuant to the Act, constitute a lien upon the respective parcels of land assessed and such lien shall be of the same character and effect as the lien created for the Township of Greenbush or the Charter Township of Oscoda taxes (as applicable) and shall include accrued interest and penalties. A judgment,

decree, or any act of the Board vacating a special assessment does not destroy or impair the lien upon the premises assessed for the amount of the assessment as may be equitably charged against the premises, or as by a regular mode of proceeding might be lawfully assessed on the premises.

8. That the special assessments made in the confirmed Roll are hereby ordered and directed to be collected and the Township Clerks of the Township of Greenbush and the Charter Township of Oscoda shall each deliver the Roll to the respective Township Treasurers of the Township of Greenbush and the Charter Township of Oscoda with a warrant attached thereto, which shall command the Township Treasurers of the Township of Greenbush and the Charter Township of Oscoda to collect the special assessments in the Roll (within their respective township) in accordance with the direction of the Board and which warrant shall further require the Township Treasurers of the Township of Greenbush and the Charter Township of Oscoda on the first day of September following the date when any such assessments or any part thereof have become due to submit to the Board a sworn statement setting forth the names of the persons delinquent, if known, a description of the parcels of land upon which there are delinquent assessments and the amount of such delinquency including accrued interest and penalties computed to September 1 of such year. The form of the warrant is attached hereto as Exhibit B.

9. That upon receiving the Roll and warrant, the Township Treasurers of the Township of Greenbush and the Township Treasurer of the Charter Township of Oscoda shall each proceed to collect the several amounts assessed therein as the same become due.

10. That the assessments shall be allocated and collected based on a per taxable parcel basis, as set forth in the Roll, and that the assessments shall be apportioned to each taxable parcel (or portions thereof) set forth in the Roll and as shown on Exhibit C.

11. If the Treasurer of the Township of Greenbush or the Treasurer of the Charter Township of Oscoda reports as delinquent any assessment or part of a Township of Greenbush or of a Charter Township of Oscoda assessment, the Board shall certify the delinquency to the assessing official, who shall reassess, on the annual tax roll of the Township of Greenbush or of the Charter Township of Oscoda of that year, in a column headed "special assessments", the delinquent sum, with interest and penalties to September 1 of that year, and an additional penalty of 6% of the total amount. Thereafter, the statutes relating to taxes shall be applicable to the reassessments in the Township of Greenbush and the Charter Township of Oscoda.

12. That the Chairman of the Cedar Lake Improvement Board shall, as soon as possible but in no event more than seven (7) days after confirmation of the Roll, send notice of the special assessment, in the form attached hereto on Exhibit D, to the person responsible for payment of the ad valorem property taxes or the record owner of or the party in interest in (whichever is applicable) each parcel of land assessed, at the address shown for such persons upon the last Township of Greenbush or Charter Township of Oscoda tax assessment rolls for ad valorem tax purposes, subject to any subsequent changes in the names and addresses of the owners or parties listed thereon.

13. When the Board received the official certified assessment rolls from the township supervisors from the two townships, it became apparent that the total estimated number of

parcels used in the earlier calculations and resolutions for the special assessment district went down by nine parcels in total (i.e. the number of estimated parcels went from 760 down to 751 actual parcels confirmed). Therefore, for purposes of the special assessment district and this Resolution, the Board has adjusted the value of the assessments to 751 parcels times \$150 per parcel equals \$112,650.00 per year, which is an adjustment from the earlier Resolutions in this case. The Board has reduced the annual revenue obtained by the special assessment collection but kept the amount of the special assessment levied on each parcel the same. Therefore, all prior Resolutions and actions by the Board are hereby revised and amended accordingly.

14. That all actions heretofore taken by Board officials, employees, and agents with respect to the Public Improvements and proceedings under the Act are hereby ratified and confirmed. Should anything specified in this Resolution (or any earlier resolution) be contrary to or in conflict with the Act, the relevant portion of the Act shall govern and the offending portion of this Resolution (or any earlier resolution) shall be deemed substituted with that relevant portion of the Act.


15. That all resolutions or parts of resolutions in conflict herewith shall be and the same are hereby rescinded.

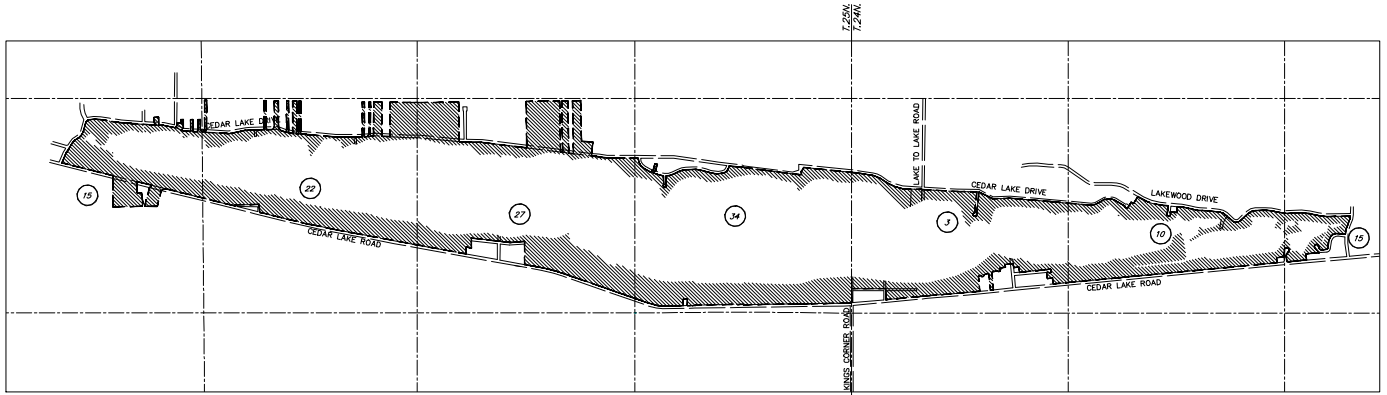

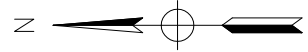
